# 1. Peter Heals a Paralyzed Man (vv. 32-35)

a. Peter traveled 25 miles northwest of Jerusalem to see the saints and give them \_\_\_\_\_

in a town called Lydda; it was predominantly a Gentile community. (v. 32)

- b. Aeneas had been \_\_\_\_\_\_ with paralysis for 8 long years; with a Greek name he was most likely a \_\_\_\_\_\_ Jew. (v. 33)

### 2. Peter Raises a Woman from the Dead (vv. 36-43)

# 3. Some Needed Reminders Regarding Signs, Wonders, and Healings
